A board motion was made to accept the 2022 meeting minutes. The motion was approved by vote.

Presidents Report:

Curt reported that he has been working with city manager Chad Sweet on signage for the neighborhood resulting in a new "Dead End" sign prior to the approach of the habitat. Additional signing may require city approval, with the expense borne by the HOA.

The Architecture and Review Committee has recently been comprised of the current board members. A proposal was made and supported to form a committee comprised of at least one board member. Members serving on this committee are:

A committee has been formed to review best practices for the maintenance of the butterfly habitat and will work in coordination with the North Coast Land Conservancy to promote both the beauty and effectiveness of the habitat. Among the items to be addressed are the mowing schedule, seeding of wildflowers to attract pollinators and the silver spot butterfly, water, and fencing needs. Committee members are as follows:

TJ McDonald noted that there are streetlamps that need new bulbs. Our previous vendor for this service, Borland Electric, is no longer in business and a replacement needs to be found that meets the requirement of having a bucket lift to reach the bulbs. It was suggested that J&J Electric be contacted.

A reminder was given that our CC&R's require that garbage cans are to be secure and stored out of the view of neighboring properties.

Curt asked if email notification for board business is an acceptable form of written communication; all members present agreed.

Heather McDonald floated the idea of holding an all neighborhood garage sale next summer. None opposed but addressed the need for signage and traffic management. More information to follow.

It was reported that there has been no news of development of the 30 acres north of the butterfly habitat or discussions of a new fire department.

Candace Smith spoke about the need to coordinate emergency response efforts in our neighborhood as we are a designated temporary tsunami gathering location. We currently have 5 CERT, Community Emergency Response Team, members in our neighborhood. The CERT program educates volunteers about disaster preparedness and provides training in areas that may include fire and flooding, CPR, search and rescue etc.

Candace also mentioned that we consider a contact volunteer from the neighborhood to coordinate with the city's incident response commander to verify information regarding an inventory of equipment and resources that can be employed during an emergency. Examples would include things such as generators, chain saws, and special equipment. It can help identify those neighbors with special needs, go bags, and emergency supplies. Several members had concerns about animal deterrents that emit a noise. While not everyone can hear it, it can be detected by pets and some adults and children. TJ will follow up with the homeowner.

A request was made to allow for electronic payment of dues. The treasurer will explore the options and report back before the next dues notification in January.
